3. (a) **The following animals shall be eligible for entry into the Enrolment Book:**
- i) Brahman males and females registered with the Australian Brahman Breeders' Association Limited.
 - ii) Angus males and females registered with an Angus Society in Australia
 - iii) Commercial males and females of Brahman/Angus or Brangus breeding following inspection and approval by an inspector appointed by the Association. An inspector appointed to enrol an animal shall not have had, or intend to have a financial or breeding interest in the animal to be enrolled.
 - iv) Such cattle shall be number branded or tattooed prior to inspection and shall to a reasonable extent conform to the standard of excellence of the Association.
3. (b) Enrolment of an animal will be accepted subject to the payment of such enrolment fees and where applicable inspection fees as the Management Committee may from time to time prescribe.
